

**Social Impact Assessment Report of proposed extension of
drain and road for Package no. W-015 and W-016 under
Narsingdi Pourashava**

Narsingdi Pourashava proposed to revise Layout of D2+ R2 under Package W-015. Earlier Pourashava proposed to construct five link road with drain from Bhanbhavan road to Shangita Road (B-1-60 m, B-2-75 m, B-3-60 m, B-4-75 m, B-5-70). Due to some unavoidable circumstances these link roads cannot be possible to implement. For this reason Narsingdi Pourashava submitted a revised proposal for constructing RCC road and RCC drain in Bramondi Mor to H/O Prof. Surjakanta via Birpur Mosque from link 04 to Prof. Surjakanta house 320 m. And proposed another 20 m road and drain from Banbhavan road to H/O Ratan.

Narsingdi Pourashava proposed under Package W-016 to revise drain extension 50 m as outfall to Haridhua River in Bank Colony area under link 10-B and proposed R+D 98 m (Link- A) from Dhaka Bus Stand Road to Link- 10 via H/O Mahfuz.


The Capital Investment Plan (CIP) of Narsingdi Municipality lists a number of roads, drains without outlet of drain. On 5 February 2020, I myself with Environmental Specialist of PMU, MGSP and XEN, AE, SAE and assigned contractors of Narsingdi Pourashava have made visit to observe the proposed sites and to review the Social Impacts on proposed revised Road and drains. Findings of our visit mentioned below:

1) D1+R1 Improvement of BC Road and footpath from Pourashava Office to Brahmondi mor via Shikkha Chattar (442 m)

Considering the road and drain, it was taken for improvement from CRDP of LGED. But only drain has been constructed without improvement of road. The road is very much important because it is connected with different government offices, Upzila H/Q, Judge Court etc. In view of this Narsingdi Pourashava has proposed to improve this road under BMDF funding. No households, shops will be affected by this proposed improvement of road. Narsingdi Pourashava can take the road for improvement.

2) Construction of outfall at Bank Colony area with link road.

There is a road in Bank Colony area under link 10-B which has no outfall. The drain will create water logging in the adjacent areas. Hence the Narsingdi Pourashava has proposed for a outfall at Haridhua River which will be 50 m length from the existing drain. Narsingdi



Pourashava should construct the outfall of drain maintain required slope. Before civil work started of this outfall Pourashava will need to obtain consent of landowners.


3) a) **RCC road and RCC drain in Bramondi Mor to H/O Prof. Surjakanta via Birpur Mosque from link 04 to Prof. Surjakanta house 320 m.**

b) **Link 10 A at Bank Colony Area 98 m**


c) **Forest Office Road to H/O Ratan – 20 m**

All the above link roads and drains are interconnected with each other. Proposed improvement will enhance the internal communication facilities of urban peoples as well as complete drainage network under the Pourashava. No household or shops will be affected. No income and livelihood will be hampered. Narsingdi Pourashava may construct the above link road and drains for smooth communication and drainage system as well.
